



## HOW TO SUBMIT YOUR IMAGES TO DHG

### #1. SELECT IMAGES

Edit down to your best images only. You are welcome to submit as many images as you like, and can submit from multiple models and shooting sessions.

Style-wise, we are open to seeing all types of images of handsome men: closeups or full body, clothed or shirtless, color or b/w, fun lifestyle or sexy high fashion. Please note we can't publish nudes.

You don't have to submit model releases to us with your submission, but you need to have them in your own files for each model, in case we request them. A sample model release is attached that you can use as reference. If you would like to go the extra mile, please feel free to have your models sign our release and include in the zip--saves you from having to dig it up if/when we need it.

### #2. PREP IMAGES

Size your images to 640x960 pixels.

Save as JPEGs with compression level set to 12 (or highest quality with least amount of compression possible).

Name your images as follows: "YourLastName\_ModelsLastName\_ImageNumber". Here's an example:

Young\_Smith\_01  
Young\_Smith\_02  
Young\_Perlman\_01  
Young\_Perlman\_02

### #3. SIGN THE LICENSING AGREEMENT

Fill out the attached Licensing Agreement, scan it (or take a photo with your phone) and upload with your image submission. This document gives us permission to publish your photos and we cannot accept a submission without it.

### #4. UPLOAD YOUR PHOTOS

To submit your photos, use a service like Google Drive or You Send It. Remember to include the Licensing Agreement in your upload.

### #5. SIT BACK AND RELAX

If your images are selected for publication, you'll be the first to know! We do review each and every image that is submitted to us, so please be patient ... this can take some time, depending on our workload. We look forward to seeing your work!
